WAIVER OF TRIAL AND MOTION FOR DEFERRED DISPOSITION

I, the above defendant in this case, hereby make my motion for deferred disposition in this matter. In connection with this motion, I enter a plea of: (mark one) [ ] GUILTY or [ ] NOLO CONTENDERE (No Contest)

I hereby waive my right to a jury trial or a hearing by the court and I further understand that by entering this plea I am acknowledging either that the State has complied with all of my requests for discovery or that I have made no such requests.

By signing below, I affirm I meet and understand the following conditions:

- 1. I do not have a Commercial Driver's License currently and I did not have one at the time of offense; (copy of valid DL or ID must be submitted with request or request will be denied)
2. The offense committed was not in a construction zone with worker's present;
3. I am not currently on a Deferred Disposition with the City of Forest Hill;
4. I will be required to pay a special expense fee and court costs in the amount of \$\_\_\_\_\_; (call for amount or see the Fines section of the website and add \$30 to the amount due)
5. I will be placed on a 90 day probation period in the City of Forest Hill during which I cannot receive any other citations during this period;
6. If I was under the age of 25 at the time of the offense and I was charged with a moving violation, I will be required to take a Driver's Safety Course (DSC) within 60 days of the granting of this motion; (court paperwork will reflect if DSC required)
7. I understand that if I comply with all the conditions of my probation at the end of the probation period the Judge will dismiss the citation without a final disposition and this charge will not be reported to my record;
8. I understand if I fail to comply with any of the conditions I will be required to appear at a Show Cause Hearing with the Judge and notice will be sent to the last address on file. Failure to appear will result in Capias Pro Fine warrant for my arrest and may result in a conviction on my record.
